- 2. Permission to fell the trees is granted at his/her own risk and without prejudice to the claims of the other person/s who may be
- 3. having any right over the land of trees.
- 4. Felling of trees shall be completed within 45 days. Incase trees felling not competed with in 45 days, application shall be forwarded to this office trough concern Range Forest Officer for Extension of time limit for felling
- 5. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
 - 6. He/She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June, 2021 to Sept, 2021 in the property from where the trees will be felled.
