2nd Interim report of the Review Committee on review of Private Forest provisionally identified by North and South Goa Forest Division Committees (V.T. Thomas & F.X. Araujo Committee)

A committee (hereinafter referred as Review Committee”), to review Provisionally identified Private Forest areas by North and South Goa Forest Division Committees (also known as Thomas & Araujo Committee) was constituted vide Government of Goa Notification No. (WP)/Pvt. For/16(THC)/ 2013(WZ)/19-20/26 dated 21/01/2020 (with Conservator of Forests as Chairman) and Vide Notification No. DCF (WP)/Pvt. Forest/16(THC)/ 2013(WZ)/19-20/119 dated 18/06/2020 (The Chief Conservator of Forests was made the Chairperson). First Interim Report of the Review Committee disposing 858 Survey Nos was submitted to the Govt. approval vide DCF (Working Plan) office note dated 26.04.2021 which may be seen at **Annexure I**. For criteria and methodology 1st interim report may kindly be referred. Following the same criteria and methodology the Committee has undertaken further review work.

An extensive ground verification, enumeration and survey exercise on survey numbers qualifying on area & canopy density criteria has been done in the field for evaluating tree composition criteria. Rains, first due to cyclone Taukte (14-19 May, 2021) and the sporadic pre- Monsoon rains till start of Monsoon rains from 5th June affected the field work and enumeration teams were unable to take up survey and enumeration field works during the period of rainy days. Even on rain free days, due to the Second wave Covid pandemic which started around 3rd week of April, 2021 in Goa and then due to curfew imposed, most of the objectors were not attending the field survey. In a few places public opposition has been seen against conducting field survey, e.g. Naquerim-Quepem, Canacona, Mollem-Dharbandora etc. Further, the shortage of

surveyors also affected the progress of survey and enumeration work.

However, despite all the above constraints substantial progress has been made. The status of progress achieved in enumeration of private forest areas as on date is shown as under:

Thus it can be seen that roughly 50% of the total area to be enumerated (9183 Ha) has been enumerated. Accordingly, in the 11th review committee meeting held on 10/6/2021, it was decided to submit the 2nd Interim Report in continuation to the First Interim Report, with the progress made in the review of additional Survey Numbers provisionally identified as private forest.

A. Survey Numbers identified as Private Forest by Sawant and Karapurkar committees and found partly repeated in Thomas & Araujo Committee:

There are a total of 130 such survey numbers across 39 villages were analysed partly/fully repeated and out of which 88 have been found fully repeated and accordingly status reported in the first Interim Report. Remaining 42 Survey Nos along with its 56 parts were reviewed by the Review Committee and the present Review Committee, after detailed analysis through Google Timeline change corroborated by LISS III FCM 2012-13, Division offence case, Tree Felling, FCA & Court order etc. found that in **05 Survey Numbers balance area does not qualify the criteria of private forests.**


(Annexure-II). Balance 37 survey numbers are still to be reviewed in the field.

B. Survey Numbers identified as Private Forest by earlier demarcation team of the Forest Department (adjoining the Survey Nos. identified as Private Forest by Sawant and Karapurkar Committee) and found partly repeated in Thomas & Araujo Committee :

In the first interim report, the Review Committee had found that out of total of 39 Survey numbers, adjoining Survey Nos of Sawant and Karapurkar Committee which were demarcated as Private Forests by earlier demarcation team of Forest Department during 2003-2008 were found fully/partly repeated in Survey Numbers identified by Thomas and Araujo Committee. In 1st interim report, two survey numbers were found fully repeated. Therefore, now the committee has reviewed the remaining 37 survey numbers and after detail analysis through Google Timeline change corroborated by LISS III FCM 2012-13, Division offence case, Tree Felling, FCA & Court order etc. found that **in 17 Survey Numbers which are partly repeated, the balance area does not qualify the criteria for Private Forest (Annexure III).** Balance 20 survey numbers are still to be reviewed in the field.

C. Survey Numbers recorded as Government Forests and found mention as Private Forest by Thomas and Araujo Committee:

Further, there are a total 26 survey numbers of recorded Forest which have been identified as Private Forest by Thomas & Araujo Committee in its report. In the first interim report, it was decided to exclude survey numbers pertaining to Reserve Forest and to review Proposed Reserve Forest and Unclassified Forest under private ownership (*if any*) in the instant case for further analysis. 8 Survey Numbers were found fully under Government ownership. **In the remaining 18 such survey numbers, no survey number could be excluded solely on area and canopy criteria.**

D. Survey numbers not qualifying Area & Canopy Density Criteria:

In the first Interim Report, the Committee undertook the Review of 747 survey numbers not meeting area & Canopy density criteria as per LISS IV Forest Cover Map 2014-15 (Forest Survey India) and based on the analysis of LISS IV Forest Cover Map 2014-15 (Forest Survey India, Google Timeline changes corroborated by LISS III Forest Cover Map 2012-13, North & South Goa Divisional history for offence cases, illegal felling, Tree Felling permissions, FCA & Court orders (if any) etc. and after detailed discussion and deliberations the committee decided that the 747 survey numbers are not qualifying the criteria to be identified as Private Forests.

Now the Review Committee, undertook review of other 322 survey numbers which are not qualifying Area & Canopy Density Criteria and based on the detailed analysis of North & South Goa Divisional history for offence cases, illegal felling, Tree Felling permissions, FCA & Court orders (if any) etc. and after detailed discussion and deliberations, the committee decided that **additional 322 survey numbers are also not qualifying the criteria to be identified as Private Forests. (Annexure-IV).**

E. Report based on Enumeration results of Survey numbers fulfilling area and canopy criteria.

The field reports submitted by Sub-Committees were placed before the Review Committee. The Committee has reviewed the survey numbers qualifying as private Forests and conducted the hearing of objections/representations. In case of non-qualifying survey numbers based on enumeration results submitted by the Divisions/sub-committees, detailed analysis through Google Timeline change corroborated by LISS III FCM 2012-13, Division offence case, Tree Felling, FCA & Court order etc was done. After detailed evaluation, deliberations and discussion on each report, the decision of the committee on these 34 Survey Numbers is enclosed as **Annexure-V.**





Summary of the Report


i) In the second interim report, by disposing of an additional 378 Survey Nos, a total 1236 out of 3195 Survey Nos has been completely disposed off. Details of such survey numbers are submitted to the Government as indicated in the Annexures, summary of which is reproduced below.

ii) Out of around 9183 Ha qualifying canopy and area criteria, ground verification, enumeration & survey of area of approximately 4427 hectares have been completed as on 10.06.2021. Thus, enumeration of around 50% area is complete. With the onset of monsoon further field survey and demarcation works have been affected slowing down review work. Balance area (around 4500 Ha) is to be verified, surveyed & demarcated on ground after monsoon, for which additional time is essential.

Subject: Interim report of the review committee constituted for identification of Private Forest provisionally identified by North and South Goa Forest Division Committees (also known as Thomas & Araujo Committee)

A committee (hereinafter referred as Review Committee"), to review identified Private Forest areas by North and South Goa Forest Division Committees (also known as Thomas & Araujo Committee) was constituted vide Government of Goa Notification No. (WP)/Pvt.For/ 1920/5170 dated 21/01/2020 under Chairmanship of CF(Conservation) and consisting of Additional Collectors (North and South), Director (Agriculture), Director (survey and Land Records), ACF (HQ) (North and South) with DCF (Working Plan) as Member Secretary. Vide Notification No. DCF (WP)/ Pvt. Forest/ 19-20/119 dated 18/06/2020, the Chief Conservator of Forest was appointed as committee Chairperson , copy at 13/C to 135/C

So far ten meetings of this review committee has taken place. The minutes of the meetings has been placed in the file at 136/C to 184/C respectively.

Progress of Review Committee so far:

1. All the Survey numbers (more than 3195 nos) included by the two Forest Division Committees (North and South Goa) - Thomas & Araujo Committee were digitized using the Regional Plan of Town & Country Planning Department, Government of Goa and records of Directorate of Survey & Land Records Department. All these provisionally identified private forest by earlier Thomas & Araujo committee report has been digitized.
2. The Forest Cover Map (FCM) of 2014-15 prepared by FSI constitutes polygons with more than 40% canopy and area more than 5 Ha and less than 5 Ha, with later analysed for proximity to Government Forest. Digitised Survey numbers of North and South Goa Divisions (Thomas and Araujo)committees have been superimposed on FCM maps/polygons of FSI for analysis
3. The enumeration of 9183 Ha (91.83 Sq. Km) approximate area is being carried out by 16 Nos. Sub-committee consisting of Range Forest Officers of Forest Department, Inspector of Survey and Land Records, Directorate of Land and Survey Department and Village Talathi of

Revenue Department, which are working under direct supervision of concerned territorial DCF.

4. The ground verification and enumeration has commenced from November, 2020 after the end of monsoon and still it is in progress. The sub-committees are inviting objectors, plotting sample plots @ 5% sampling intensity (Similar method adopted by earlier review Committee in its report and the report was accepted by Hon'ble NGT in O.A. No. 479/2018), marking and enumerating trees, preparing reports, preparing maps after survey for area qualifying. Concerned territorial Deputy Conservators of Forest are directly supervising and also providing support of equipment, manpower etc. As on date the teams has completed enumeration of an area of **2417 Ha** and it is anticipated to complete another **1500 Ha** of area before the onset of monsoon.

An interim report with Annexure I, II, III, IV and V of the review committee has been finalized, following the approved methodology to complete the assigned task, copy placed at 185/C, which is briefly reproduced below-

A. Survey Numbers identified as Private Forest by Sawant and Karapurkar committees and found repeated in Thomas & Araujo Committee :

Hon 'ble NGT in O.A. No. 479/2018 has accepted the Report on review of Survey Nos identified as Private Forests by Sawant and Karapurkar Committee. However, there are Survey Nos (partly or fully) of Sawant and Karapurkar committees, found repeated in Thomas & Araujo Committee. In view of Hon'ble NGT are not to be reviewed. There are a total 130 such survey numbers across 39 villages were analysed and out of which 88 have already been completely reviewed and remaining 42 Sy Nos along with its 56 Survey nos parts needs to be reviewed. **(Annexure I of the interim report).**

B. Survey Numbers demarcated by earlier demarcation team of Forest Department adjoining to sy Nos identified as Private Forest by Sawant and Karapurkar, included as such by previous review committee and accepted by Hon'ble NGT in O.A. No. 479/2018:

Similarly, a total of 39 Survey Nos. not of Sawant & Karapurkar committee but adjoining it has also been identified as Private Forest by earlier demarcation

team of Forest Department and the same has been reviewed as such by earlier Review Committee under the DCF (WP) and also accepted by Hon 'ble NGT as a Forest in 46.11 sq. km. area. In view of Hon 'ble NGT order, in 39 adjoining Sy Nos, 2 No. Sy Nos 25 and 101 of Keri (Sattari) are not to be reviewed, in the remaining 37 the undemarcated area will be reviewed by this Review Committee. (Annexure II of the interim report)

C. Survey Numbers recorded as Forests :

Further, there are a total 26 Sy. Nos. of recorded Forest which have been identified as Private Forest by Thomas & Araujo Committee in its report. It was decided to exclude Sy Nos. pertaining to Reserve Forest and to review Proposed Reserve Forest and Unclassified Forest under private ownership (If any) in the instant case for further analysis. (Annexure III of the interim report)

D. Survey numbers not qualifying Area & Canopy Density Criteria :

The Committee also undertook the Review and found 747 Survey Nos not meeting area & Canopy density criteria and after detailed discussion and deliberations decided to be not qualifying to be identified as Private Forests, based on the analysis of LISS IV Forest Cover Map 2014-15 (Forest Survey India) , Google Timeline changes corroborated by LISS III Forest Cover Map 2012-13, North & South Goa Divisional history for offence cases, illegal felling, Tree Felling permissions , FCA & Court orders etc., (if any) . (Annexure IV of the interim report)

E. Report based on Enumeration results of Survey numbers fulfilling area and canopy criteria.

An extensive ground verification, enumeration & survey exercise of qualifying Area and canopy criteria has been initiated since November 2020, to evaluate the Tree composition criteria. Based on the field analysis report following status of review work is as below (As on 10.04.2021)

The Committee has reviewed, the survey numbers qualifying as Private Forests with public hearing and Non Private Forests based on enumeration results submitted by the Divisions/ sub-committees are enclosed (**Annexure V of interim report**).

Further, approximately as on date, the teams has completed enumeration of an area of **2417 Ha** and it is anticipated to complete another **1500 Ha** of area before the onset of monsoon. Public hearing of affected parties / owners/ objectioners whose areas are qualifying the criteria of private forest is in progress.

With this interim report out of 3195 total survey nos provisionally identified as Private forest by North and South Goa Forest Division Committees (also known as Thomas & Araujo Committee) around 860 Nos are fully disposed off and around another 100 are partly disposed off .
