- 1 Applicant shall replant 3 forestry tree species during ensuing/ next planting season, i.e. commencing from June 2021 to August 2022 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 72/32 of Betalbatim village Salcete taluka.
- 2 Licence fee was paid earlier vide R. No. 40/4130 dated: 17.08.2021 Rs. 100/- and deposit a sum of Rs 600 (RUPEES SIX HUNDRED ONLY) as Security Deposit in the office of the Sub-Divisional forest officer, South Goa Division, Quepem Goa before starting felling of the tree/s for ensuring the replanting of the trees indicated at Sr.No. 51 above.

3. Copy to:- Range Forest Officer MS with reference to in report/LMB dated 16.07.2021. He is directed to keep strict watch over the felled materials and insure that no illegal material should be allowed to transport. He should also issue the transit passes to the applicant.
