Terms and conditions

- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
- 3. Felling of trees shall be completed within <u>45</u> days from the above mentioned date and felling to be commenced after <u>30 days</u> from the date of issue of this license as per the directions of Hon'ble High court in Writ Petition No.08 of 2021.
- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. Applicant shall replant 6 forestry tree species during ensuing/next planting season i.e. commencing from June 2021 to August 2022 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy.No.166/21 of Chaudi village of Canacona taluka.
- 6. License fee was paid earlier vide R. No. 4067/90 dtd. 12/10/2021 for Rs.200/- and deposit a sum of Rs.1200/- (Rupees one thousand two hundred only) vide D.D.No.720845 dtd.11/10/2021, as Security Deposit in the office of the Sub Divisional Forest Officer, Canacona-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr.No.5 above)
- 7. In the event of failure on the part of permit holder to replant the trees as indicated at Sr. No. 5 above, then the Tree Officer, shall himself undertake to replant the trees and recover the cost thereof from the permit holder by way of adjustment against the Security Deposit made by the applicant.

 - 2. Copy to: The Range Forest Officer, Canacona w.r.t. his report dated 24/03/2021. He is directed to keep strict watch over the felling of 02 trees and ensure that no illegal felling takes place.
 - 3. Copy to the Chairman/Secretary, Chaudi village, Biodiversity Management Committee, Village Panchayat, Canacona Goa.
