Terms and conditions

- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
- 3. Felling of trees shall be completed within 45 days from the above mentioned date.
- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. Applicant shall replant 06 nos. of forestry trees species during ensuing/next planting season, i.e. commencing from July 2021 to Oct.2021 in the property from which the trees will be felled.
- 6. Applicant shall deposit a sum of Rs.1200/- (Rupees one thousand two hundred only) vide as security Deposit in the office of the Sub Divisional Forest Officer, South Goa Division, Canacona-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr. No. 5 above).
- 7. In the event of failure on the part of permit holder to replant the trees as indicated at Sr. No. 5 above, then the Tree Officer, shall himself undertake to replant the trees and recover the cost thereof from the permit holder by way of adjustment against the Security Deposit made by the permit holder or falling that by recovery as arrears of Land Revenue.

- a) License fee was paid vide R. No. 4067/84 dtd. 26/07/2021 for Rs. 200/-
- b) Security Deposit of Rs.1200/- vide D. D. No. 017094 dtd. 22/07/2021 from Union Bank of India, Poinguinim Goa branch Deposited
- 1. Copy to the RFO, Canacona w.r. to his report dtd 12/07/2021. He is directed to keep strict watch over the felling of 2 nos. of trees and ensure that no illegal felling takes place.
