- The Range Forest Officer shall be responsible for accounting.
- Permission to fell the trees is granted at his/her risk and without prejudice to the claim of the Other persons who may be having any right over the felled trees.
- Felling of trees shall be done after 30 days from issue of this permission and should be completed within 45 days.
- Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- He/She shall replant trees as per details given below during the ensuing/next planting season i.e. Commencing from June 2021 in the property from which the trees will be felled.
