## Terms and conditions

- 1 The Range Forest officer shall mark the tree before cutting.
- 2 Permission to fell trees is granted at his/her own risk and without prejudice to claim(s) of any other person/s who may be having any right(s) over the land or the trees.
- Felling of trees shall be completed within <u>45</u> days from the above mentioned date and felling to be commenced after 30 days from the date of issue of this licence as per the directions of Hon'ble High Court in Writ Petition No. 08 of 2021.
- 4 Material produced from the felled trees shall not be removed or disposed without permission of the tree officer.
- 5 Applicant shall replant 3 forestry tree species during ensuing/ next planting season,i.e,commencing from June 2021 to August 2022 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 147/1 of Rivona village Sanguem taluka.
- 6. Licence fee was paid earlier vide R. No. 4136/08 dated: 01.09.2021 Rs. 200/- and deposit a sum of Rs 600 (Rupees Six Hundred Only as Security Deposit in the office of the Sub Divisional forest officer, South Goa Division, Quepem Goa before starting felling of the tree/s for ensuring the replanting of the trees indicated at Sr.No. 5 above.
- 7. In the event of failure on the part of permit holder to replant the trees as indicated at Sr.No. 5 above, then the Tree Officer shall himself arrange to replant the trees and recover the cost thereof from the permit holder by way of adjustment against the Security Deposit made by the applicant.

- 2. Copy to the Dy. Conservator of Forests, Head Quarter, Panaji Goa to upload on the website.
- 3. Copy to:- The R.F.O. Quepem with reference to his report dated 18.05.2021. He is directed to keep strict watch over the felled Two trees and ensure that no illegal felling takes place.
- 4. Copy to the Chairman/Secretary, Rivona , Biodiversity Management Committee, Village Panchayat, Rivona , Sanguem Goa to followup replanting of trees.
