## Terms and conditions

- 1 The Range Forest officer shall mark the tree before cutting.
- 2 Permission to fell trees is granted at his/her own risk and without prejudice to claim(s) of any other person/s who may be having any right(s) over the land or the trees.
- 3 Felling of trees shall be completed within <u>45</u> days from the above mentioned date and felling to be commenced after 30 days from the date of issue of this licence as per the directions of Hon'ble High Court in Writ Petition No. 08 of 2021.
- 4 Material produced from the felled trees shall not be removed or disposed without permission of the tree officer.
- 5 Applicant shall replant 21 forestry tree species during ensuing/ next planting season,i.e,commencing from June 2021 to August 2022 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 36/0 (Area 6914 Sq Mts.) of Navelim village Salcete taluka.
- 6. Licence fee was paid earlier vide R. No. 4149/25 dated: 21.01.2022 Rs. 700/- and deposit vide DD No. 362389 dated: 19.01.2022 a sum of Rs 4200 (Rupees Four Thousand Two Hundred Only as Security Deposit in the office of the Sub Divisional forest officer, South Goa Division, Quepem Goa before starting felling of the tree/s for ensuring the replanting of the trees indicated at Sr.No. 5 above.
- 7. In the event of failure on the part of permit holder to replant the trees as indicated at Sr.No. 5 above, then the Tree Officer shall himself arrange to replant the trees and recover the cost thereof from the permit holder by way of adjustment against the Security Deposit made by the applicant.
- 1. Copy to the Conservator of Forests, Panaji-Goa, for information
- 2. Copy to:- The R.F.O. (M.S.) with reference to his report dated 14.12.2021. He is directed to keep strict watch over the felled Seven trees and ensure that no illegal felling takes place.
- 3. Copy to the Chairman/Secretary, Navelim , Biodiversity Management Committee, Village Panchayat, Navelim , Salcete Goa to followup replanting of trees.
