Terms and conditions

- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
- 3. Felling of trees shall be completed within <u>45</u> days from the above mentioned date and felling to be commenced after 30 days from the date of issue of this licence as per the directions of Hon'ble High Court in Writ Petition No. 08 of 2021.
- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. He/She shall replant tree as per details given below during ensuing/next planting season, i.e. commencing from June 2021 to August 2022. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 102/6-B-1 of Cortalim village Mormugao taluka.

- 6. Licence fee was paid earlier vide R. No. 46/4155 dtd. 20/4/2022 for Rs. 4300/- and deposit a sum of Rs. 25800/- (Rupees twenty five thousand eight hundred only) vide F. D. No. 50300615027864 dtd. 20/4/2022, as security Deposit in the office of the Dy. Conservator of Forests, South Goa Division, Margao-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr. No. 5 above).
- 7. In the event of failure on the part of permit holder to replant the trees as indicated at Sr. No. 5 above, then the Tree Officer, shall himself undertake to replant the trees and recover the cost thereof from the permit holder by way of adjustment against the Security Deposit made by the permit holder or falling that by recovery as arrears of Land Revenue.
- 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated nos. of saplings otherwise, Security deposit shall be forfeited in 'Tree Protection Fund-Goa'.
- 1. Copy to the Conservator of Forests, Panaji Goa for information.
- 2. Copy to the **RFO**, **Mobile Squad Margao** w.r. to his report dated 02/03/2022. He is directed to keep strict watch over the felling of 43 nos. of trees and ensure that no illegal felling takes place.
- 3. Copy to the Chairman/Secretary, Cortalim, Biodiversity Management Committee, Village Panchayat, Cortalim, Mormugao Goa to followup replanting of trees.
