## Terms and conditions

- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
- 3. Felling of trees shall be completed within 45 days from the above mentioned date and felling to be commenced after 30 days from the date of issue of this licence as per the directions of Hon'ble High Court in Writ Petition No. 08 of 2021.
- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. He/She shall replant trees as per details given below during ensuing/next planting season, i.e. commencing from June 2022 to August 2023. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 123/8 of Barcem village Quepem <u>taluka.</u>

6. Licence fee was paid vide R.No. 11/4141 dtd. 28/10/2021 for Rs. 700/- and deposit a sum of Rs. 3,000/- (Rupees three thousand only) vide D.D.
