- 2 Permission to fell the trees is granted at his/her own risk and without prejudice to the claim of the Other person who may be having any right over the land or trees.
- 3 -Felling of trees shall be done after 30 days from issue of this permission and should be completed
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2021 in the property from which the trees will be felled.
