Sub.:- Appointment of Contractor for removal and disposal of 1st class timber wood of 02 Nos. of Teak wood trees and firewood timber at Rajbhavan.

Sir,

With reference to your letter dated 24/02/2022 on the cited above subject, and in pursuance of Circular No. 13-3-90-FOR dated 15/11/1991. No Objection of Forest Department is hereby conveyed for cutting of felling of 02 Nos. of Teak trees fallen slanted on other trees at Jackfruit garden in Raj Bhavan which is posing threat to life and property at Rajbhavan campus in Donapauola in Tiswadi taluka,

subject to following Terms and Conditions:-

1. In case of any claim / litigation about the ownership of the tree /land in question, applicant/user agency will be solely responsible.
2. The cutting of trees shall be carried out after receipt of all other statutory permissions from competent authority, as applicable.
3. Date of beginning for cutting of tree is to be intimated to Range Forest Officer, Panaji well in advance.
4. A separate register showing details of cutting (like tree No, number of logs made out of each tree etc.) needs to be maintained by the applicant/user agency. The same shall be produced to the officer inspecting the site.
5. **Felling of trees shall be completed before 15th July, 2022. In case tree felling not completed within given period of time, application shall be forwarded to this office through concerned Range Forest Officer for Extension of time limit for felling of trees.**
6. To compensate the loss User Agency/Applicant is hereby advised to plant tall saplings with good endurance with minimum 8-10 feet height and 10cm diameter at 1 mtr. Height from ground level.
7. The applicant/User Agency should replant 06 Nos. of trees saplings in lieu of felling of 02 Nos. of tree in their own land and submit compliance report along with photographs to this office.


