

TERMS AND CONDITIONS		
Sr. No.	Species	No.
1 -	The Range Forest Officer shall mark trees before cutting.	
2 -	Permission to fell the trees is granted at his/her own risk and without prejudice to the claim of the Other person who may be having any right over the land or trees.	
3 -	Felling of trees shall be done after 30 days from issue of this permission and should be completed within 45 days.	
4 -	Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.	
5 -	He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June-2021 in the property from which the trees will be felled.	
	Applicant should plant 06 No. Misc species	06
6 -	He/She has paid of Rs. 200/- vide Receipt No. 01 /754 dtd: 01.02.2022 as fee. He/She has deposited a Sum of Rs. 1200/- (One thousand two Hundred only) Receipt No. 13 /753 dtd. 01.02.2022 as security in the office of the Dy. Conservator of Forests, before starting the felling of trees for ensuring the planting of tree indicated at above serial No.5 .	
7 -	In the event of failure on the part of permit holder to replant the trees as indicated at serial No. above Then the Tree Officer shall himself arrange to replant the trees and recovery the expenditure as Areas of land Revenue.
