In case trees felling not completed within 45 days application for extension of time limit for felling of tree, shall be forwarded to this office through concern Range Forest Officer
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2022 in the property from Which the trees will be felled.

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.
