- 3 The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentined above. Incase trees felling not completed within 45 days application for extention of time limit for felling of tree shall be forwarded to this office through concern Range Forest Officer
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2022 in the property from which the trees will be felled.

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10feet height.
