#### HON'BLE CHIEF MINISTER'S FUNCTION DURING MEGA TREE PLANTATION DRIVE - 2008

The conclusion of the Mega Tree Plantation Drive week 2008 was marked by a planting ceremony organized by the Goa Mineral Ore Exporters Association at Pale Mines of M/s. Chowgule & Company Private Limited on 20th June, 2008. The Hon'ble Chief Minister of Goa, Shri Digamber Kamat, the Chief Guest on the occasion, planted a sapling. A large number of trees were planted by the officials of the Forest Department and the GMOEA and representatives of the mining industry and the general public.

During the valedictory function, the Chief Guest emphasized the role played by the mining industry in the economy of the State right from Portuguese times. The natural resources have to be exploited, at the same time maintaining the environmental safeguards. The Hon'ble CM lauded the efforts of the Hon'ble Forest Minister, Secretary (Forests) and the officers of the Forest Department in taking up this unique drive to plant maximum number of trees. The GMOEA has taken up a target of planting 5 lakh saplings in a period of one month.

The function was well attended by the government officials, officials of the GMOEA, representatives of the mining industry, panchayat members, school students and public.

#### **MEGA TREE PLANTATION DRIVE - 2008**





The Forest Department, launched the Mega Tree Plantation Drive 2008 during this monsoon season. The aim is to plant 5 lakh seedlings in 5 days, from June 16th to June 20th; and 10 lakh seedlings during the remaining monsoon period. The total target is 15 lakh seedlings. Other Departments and institutions are involved in the plantation drive, and the targets set out are, 10 lakh seedlings are to be planted by Forest Department, 1.5 lakh seedlings by the Panchayats, 0.5 lakh seedlings by Schools, and the rest by other Government Departments, the NGOs, Mining Companies etc.

The Forest Department raised about 15 lakhs seedlings in its 28 Forest Nurseries spread over the entire State of Goa. The seedlings





are mostly of forestry species, but also include 3 lakh seedlings of edible-fruit bearing species like Jamun, Avala, Jackfruit, Cocum etc. The seedlings required for planting in the Mega Tree plantaion drive by the Government Departments, Panchayats, Schools and NGOs, shall be provided free of cost by the Forest Department.

Each Forest Division has been designated as Nodal Forest Division for the Talukas and they shall transport seedlings from the forest nurseries to plantation sites identified by the Panchayats, Schools.

The Mega Plantation Drive was kicked off on June 16<sup>th</sup> at a function at Government Polytechnic, Curchorem. Ceremonial planting was done by H.E. the Governor, Hon'ble Minister for Forests, M.L.A. Curchorem, officials and school children. The closing function for the week was conducted at Pale mines of M/s. Chowgule & Co. The Hon'ble Chief Minister of Goa was the Chief Guest on the occasion.



#### **ENACTMENT OF RECOGNITION OF FOREST RIGHTS ACT**

In the year 2007, Government of India enacted "THE SCHEDULED TRIBES AND OTHER TRADITIONAL FOREST DWELLERS (RECOGNITION OF FOREST RIGHTS) ACT 2006 (No. 2/2007)" and also passed the "The SCHEDULED TRIBES AND OTHER TRADITIONAL FOREST DWELLERS (RECOGNITION OF FOREST RIGHTS)

RULES, 2007 under the said Act.

The act provides 13 kinds of forest rights, to the tribals living therein.

In Goa, the Directorate of Social Welfare Department has been designated as the Nodal Agency for implementation of the Act.

#### THE RECOGNITION OF FOREST RIGHTS ACT CHALLENGED

Now that the implementation proceedings of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 have just been initiated in the country, a Public Interest Litigation under Writ Petition (C) No. 50/2008 has come to be filed in the Supreme Court of India by Bombay

Natural History Society and Others against the Union of India and others. The Writ Petition seeks to declare the enactment to be beyond the legislative competence of the Parliament and the Act's provisions ultra-vires Articles 14 and 21 of the Constitution of India.

#### **NATIONAL COMMITTEE FOR MANGROVES AND CORAL REEFS**



The National Committee on Mangroves & Coral Reefs met in Goa on 28" & 29" of March, 2008 at the International Centre, Dona Paula. Shri B. S. Parsheera, Addl. Secretary, MoEF chaired the meeting which was attended by several Heads of Department and Scientists. In all, 20 members attended the meeting. Dr. B. P. Nilaratna, Jt. Secretary (MoEF) and Dr. J. R. Bhatt, Director, were present. A presentation on behalf of the State of Goa was made by the Dy. Conservator of Forests, Research & Utilisation Division, Shri F. X. Araujo. The Committee visited the local mangrove plantation sites along the Mandovi River. The dignitaries were accompanied by Shri Anil Shetgaonker, ACF and Shri D. N. Chodanker, ACF (Retd) during the field visit.

### **AMENDMENT OF PRESERVATION OF TREES ACT, 1984**

Recently, the State legislature has passed a bill to amend The Goa, Daman and Diu Preservation of Trees Act, 1984. The amendment empowers the Dy. Collectors and Tree Officers to cut and remove those trees, including coconut palms, which are posing imminent danger to life and property. The amendment

also provides for raising of a fund called Tree Protection Fund (TPF) for enabling the Dy. Collector and the Tree Officer to incur expenditure while implementing the provisions of this amendment, whenever the need arises. The bill has been enacted into a law and has been published in the Official Gazette.

# ACHIEVEMENTS AND OTHER DEVELOPMENTS IN THE GOA FOREST DEVELOPMENT CORPORATION LIMITED

During the last 3 years, replanting of refractory areas have been taken up under the schemes of National Horticulture Mission (NHM) by planting high yielding variety of cashew grafts Vengurla 4 (V4), Vengurla 7 (V7) which will shortly go into production. Also during the year, the implementation of Frontline Technology of NHM as demonstration plots with high yielding variety of cashew grafts was taken up.

The Goa Forest Development Corporation Ltd. has been implementing the Govt. of India Scheme under the Joint Forest Management, on Care and Share basis by registering the local Self Help Groups with the Corporation for management, maintenance and fresh planting in areas under the Goa Forest Development Corporation. The aim is to involve rural people in protection, management and development of Cashew plantations, and to provide job avenues for them to supplement their family income, thereby lifting their socio-economic status, and allowing them a lead role in the protection and conservation of our resources with due regards to the environment and ecology.

The pilot project on Apiary has been implemented during the current year. To supplement the income of the corporation, bee-keeping activities in the rubber plantations at Shisheval in Canacona and Veluz in Valpoi have been started. There are also plans for commercial production and registration under AGMARK is in the process.

The Goa Forest Development Corporation has also taken up the establishment of the prestigious "Botanical Garden cum Eco-Recreational Park" on the downstream side of The Selaulim Dam. The objective of this project is to promote tourism in the hinterland and ensure a balanced development for the State of Goa. The project consists of 3 phases. The first phase is the formal gardens, which is almost complete. The second phase is the Botanical Garden which will showcase the species endemic to the Western Ghats. The third phase consists of the water park. When completed, this will be a unique feature on the tourist map of Goa.

#### SHRI MOHAMMAD AGA, R.F.O. AWARDED STATE AWARD

Shri Mohammad Aga, Range Forest Officer, presently working in the Goa Forest Development Corporation at Canacona was awarded the Goa State Award for best tree plantation in 2006-07. The award was presented to Shri Mohammad Aga at the Goa Liberation Day parade at Campal on 19/12/2007 by the Hon'ble Chief Minister of Goa, Shri Digamber Kamat. The award consists of a Brass Samai, a Certificate of merit and cash amounting to 10,000/-.

Shri Mohammad Aga was nominated for the award for outstanding and excellent plantation raised by him in Tirwal beat of Fondsorem Round in Canacona. Cashew grafts were planted over an area of 22.00 ha. at an escapement of 4m x 4m. The area is under biotic pressure and the soil is of poor quality. In spite of these adverse conditions, the survival is 99% and the growth is vigorous and healthy. The area is likely to go into production in 2008-09.

#### TRAINING OF XXVIII BATCH OF FOREST GUARDS



# **ELEPHANT MIGRATION INTO GOA.**

Elephants have been migrating out of their natural habitats in Kanrnataka during last few years. This steady and regular movement of elephants into the State of Maharastra and then into Goa, has given rise to new problems for the people, in these States, which do not have experience in dealing with elephants. This year a herd of four elephants (one tusker included) made their way into Goa in mid-May. They stayed in the forests of the eastern part of Pernem Taluka and regularly raided the nearby agricultural (Paddy) and Horticultural crops (Banana, Coconut, Arecanut, etc), thereby causing losses to the farmers. Ibrampur, Alorna, Assapur, Khutwal, Sal, Wadaval etc. are some of the affected villages. While the experience was new and scary for the people, it was a testing time for the Officers and staff of the Forest Department as well. Their efforts in driving the pachyderms to safer areas of Maharashtra did yield results after a months' hard work. The elephants moved into Maharastra during the first week of the July. But it came at a cost, Shri Rajendra K. Bhagat, Forest Guard sacrificed his life protecting the life and the property of the villagers on the night of 22.06.2008 near Alorna.

The Government released an immediate compensation of Rs. 2,00,000/- (Raising it from Rs. 40,000/- which is the notified amount paid in such cases) to the family of the deceased. A proposal to increase the rates of compensation for damage to life and property by wild animals, has been moved as decided in a meeting attended by the Hon'ble Chief Minister, Hon'ble Forest Minister, Chief Secretary and Chief Conservator of Forests among others.

The immediate strategy in tackling the problems

arising out of human-elephant conflict by the affected States has been to drive/scare the elephants out of their territory, though it is not a long term solution. The State of Goa has inherent constraints in letting the elephants stay in Goa. Its small geographical area and high degree of urbanisation are a couple of them. The fact that elephants require a large tract of forested land as habitat makes the State of Goa unviable. The apprehensions of the people affected by this conflict and their opposition may also be considered here.

The Governments of Maharastra & Karnataka have been made aware of these constraints at the highest level. The Hon'ble Chief Minister, the Hon'ble Forest Minister of Goa, along with the Secretary and the Chief Conservator of Forests have briefed their counter parts and solicited their help in dealing with the issue.

A long term action plan is being drawn up in consultation with the neighboring States of Karnataka & Maharashtra, but it might take time given the necessity that one of the bigger States has to accommodate the elephants.

Expert opinion in dealing which such humanelephant conflict mainly emphasize on long term measures (Changing crop patterns, learning to live with elephants, etc) Generally speaking they do not agree with capturing and domesticating wild elephants.

While the Department is making all efforts to minimize problems to the people due to the elephants, it is imperative that the people also realize the inherent constraints and difficulties involved in dealing with the large and endangered animals like elephants and they co-operate with the Government in handling the issue in a more sensitive way.

During the first half of this year, important International Days were celebrated at the Forest Training School, Valpoi.

International Biodiversity Day 2008 (May 22, 2008: A ceremony to mark the occasion was held in the Auditorium of the FTS, Valpoi. Shri Kanta Gaonker, agriculturist of Valpoi was the Chief Guest and Shri G.T. Kumar, IFS, Dy. Conservator of Forests was the Guest of Honour. Shri Anil Shetgaonker, ACF welcomed the gathering. The Director, FTS, Shri F.X. Araujo, IFS spoke on the relevance and importance of preserving and conserving biodiversity. The function was attended by officials of the Department and general public.

World Environment Day 2008 (June 5th, 2008): The Forest Guards undergoing training and officials of the Research Division celebrated World Environment Day by planting of medicinal plants on the campus of FTS. He was taken around the campus and briefed about the training programmes conducted in the school. ## VRIKSHA MELA – 2008



# **DEMARCATION OF PRIVATE FORESTS IN THE STATE**

The Sawant Committee, and the Karapurkar Committee appointed by the State Government, in pursuance of the Order passed by the Hon. Supreme Court in Writ Petition (Civil) No. 202/95, in their reports, had identified potential areas as Private Forests, subject to their ground verification and demarcation.

Subsequently the Hon. High Court of Bombay at Panaji, passed an Order in M.C.A. No. 350/2003 in Writ Petition (C) No. 286/2003 directing the State Government to demarcate the forest areas from the non-forest areas in the State. The Forest Department was entrusted with this job. The survey work which was

fraught with difficulties, is nearing completion. The latest report of the survey has been filed before the Hon. High Court towards the end of June 2008.

Out of the 640 holdings identified by the Sawant and Karapurker Committees, demarcation of private forests has been completed in 612 holdings. The work is in progress in 12 holdings and will be completed at the earliest. In the remaining 18 holdings, work was stopped in 6 cases due to objections/obstruction by the owners and local people. In 10 holdings, the Committees have not given any specific location i.e. no survey numbers have been given.

#### **OBITUARY**



Fate dealt a terrible blow to the Forest Department, and Pernem Range of the North Goa Division in particular, when within the span of a few days, two of our staff, Shri Kashinath P. Shetye, RF, and Shri Rajendra K. Bhagat, FG, were snatched away from us under tragic

circumstances.

Shri Kashinath P. Shetye, RF, 49 years of age, was zealously involved in the works connected with the Mega Tree Plantation Drive 2008. June 17th, 2008, he was on his way to Panaji, from Pernem, to collect tree guards required for this activity. The hired vehicle in which he was traveling, along with others, met with an accident at Dhargal, Pernem. Besides him, two other occupants of the vehicle died on the spot. Shri Shetye had a pleasant and always smiling nature. He was obedient and maintained cordial relations with his superiors, colleagues and public. He joined the Department as a Forest Guard in 1981, and was promoted to Round Forester in 2003. He is survived by his wife and two sons.

Shri Rajendra K. Bhagat, FG, 48 years of age, was posted in Pernem Range. Alorna area of Pernem Taluka, was recently in the news because of the herd of 4 elephants that had taken refuge in that area.



Shri Bhagat was one of the staff posted in that area to protect the agricultural and horticultural crops from destruction by the elephants. On the fateful night of June 22<sup>rd</sup>, 2008, while discharging his duties, Shri Bhagat was trampled by one elephant. He was a portly person with a mild disposition. Always respectful and humble.

Shri Bhagat joined the Forest Department in 1981. He is survived by his wife and two children a son and a daughter.

The Forest Department is deeply grieved by this untimely and tragic loss. Deepest sympathy and sorrow is shared with the bereaved families.
