### Agenda item no 10.1: Review of progress of ongoing field enumeration & Survey of Private Forest

1. As per the status obtained from Dy Conservator of Forests (Territorial) is as on 05.04.2021 below

North Goa Division - Area enumerated: 856.008 Ha, Area qualified and plan prepared: 57.49 Ha

South Goa Division - Area enumerated: 1695.05 Ha, Area qualified Area qualified and plan prepared: 44.05 Ha

Balance qualified area plan preparation is in progress

2. The committee decided to expedite the field work by deploying additional man force and to complete the verification work on priority, it also decided to ask DCF, North & South to personally monitor the work and achieve the maximum area coverage per week in each division despite of field difficulties and availability of labours due to ongoing festival season.( Action: DCF – North / South)

## Agenda item no 10.2: Review of Survey Nos qualifying as private forests as per field reports and also to undertake public hearing.

The Review committee discussed on the Public hearing called vide Notice no. MS/REV-PF/DCF/WP/2019-20/1216 dated 26/03/2021 conducted on 30/03/2021 and 31/03/2021 and decided the following:

Sr. No	Village – Taluka	Survey Nos	Decision of the Review Committee after public hearing.
1.	Pernem – Pernem	224/1	An area of 12.8 ha is tentatively qualifying. Committee directed to prepare a revised plan of area qualifying as private forest. The area qualifies as private Forests
2.	Dhargal – Pernem	361 & 362	An area 19.46 ha is qualifying by 5 % Sampling enumeration , after the objections were heard, it was decided to undertake complete enumeration of trees in S. No.362 again in the presence of the objectors and demarcate the extent of area qualifying as private forest and submit the plan accordingly.



3.	Quital – Quepem	75(P), 79(P) & 80(P)	An area of more than 9 ha is qualifying as private, it was decided to demarcate and prepare the extent of area qualified as private forests as per sub division wise. As the area qualifies as Private Forests
4.	Nagvem – Sattari	10/1 & 10/2	Though the area is shown non qualifying as per cumulative tree enumeration, due to less than 75% composition, the area to be verified and to ascertain the extent of area fulfilling 75% tree composition, since both survey nos are adjacent to Government Forests in Valpoi Range of Sattari Taluka.

Followed by Public hearing was conducted as called vide Notice no. MS/REV-PF/DCF/WP/2019-20/09 dated 01/04/2021 for areas qualifying as private forests in Colomba (Sanguem), Curti, Ponda (Ponda taluka) and Dabolim (Mormugao Taluka) and the review committee after detailed discussion and deliberations finally confirmed the following.

Sr. No	Village – Taluka	Survey Nos	Decision of the Review Committee after public hearing
1.	Colomba – Sanguem	50(P), 53(P)	An area of 14.51 ha & 3.62 ha respectively qualifies as Private Forest.
2.	Curti – Ponda	99 , 100	A patch of forest comprising an area of 1.90 Ha (S. No 99 – of Curti
3.	Ponda – Ponda	83 & 84	) and 1.85 ha (S. No 100 - of Curti together with 2.44 ha of S. No 83 and 1.56 ha of S.no 84 of Ponda village, together qualifies as private forest patch area of 7.75 Ha.
4.	Dabolim – Mormugao	4,9,13,14,17,22, 46 & 47	Considering the objections raised by the land owners, it was decided to conduct field verification of the area and decide accordingly



The field reports submitted by Sub Committees were placed before the Review Committee and after evaluation, deliberations and discussion on each reports the committee decided as under:

Sr. No.	Village – Taluka	Survey Nos	Decision of the Review Committee after detailed deliberations
1	Kundaim – Ponda	48/10	Based on the field reports the area does not qualify the tree composition criteria and the tree felling offence registered pertains to area outside the identified private forests. Hence, the area does not qualify the criteria of Private forests
2	Bandora – Ponda	216, 221	Based on the field reports the area does not qualify the tree composition criteria and the tree felling offence registered pertains to area outside the identified private forests. Hence, the area does not qualify the criteria of Private forests
