

MINUTES OF 8th MEETING OF THE REVIEW COMMITTEE TO REVIEW THE PRIVATE FOREST AREAS IDENTIFIED BY STATE LEVEL EXPERT COMMITTEE (THOMAS AND ARAUJO COMMITTEE) ON PRIVATE FOREST HELD ON 02.03.2021

A meeting of the Review Committee was held on 02/03/2021 at 3.30 pm in GIS LAB of Forest Department, Goa Van Bhavan, Altinho, Panaji under the chairmanship of Chief Conservator of Forests. Following attended the meeting:

Following was in attendance:-

1. Shri. Dilesh A. Gauns Desai- Chief Forest Surveyor (Working Plan Division)

At the outset the Member Secretary welcomed all the Members of Committee and informed about the action taken on decision of the previous meeting of Review committee held on 06/01/2021. It was also informed that the minutes of 7th meeting has been officially communicated to all the members.

Thereafter agenda-wise discussion held. Following was discussed /decided

Agenda item no 8.1: Update on progress made for 7th Meeting till date

1. On 7.1.2021, Hon'ble NGT in Execution Application No. 26/2020 in OA No. 478/2018 (earlier O.A. No. 16/THC/2013 (WZ) has passed order to complete the review exercise within three months time.

2. All maps/KML file has been sent to Divisions/ Sub-committee for enumeration/survey. Accordingly, filed verification is in progress and upto February month end about 375 hectares of area were visited and enumerated by the Sub Committees. At present, work of ground verification is in progress in both the Divisions.
3. The sub-committees through concerned DCF has to submit the final field geo-co-ordinates and survey plan of areas qualifying the species criteria to the Review Committee for finalization of Final Report of Plan in Time Bound manner. Enumeration report of area not qualifying as forest also has to be submitted.

Agenda item no 8.2: Regarding expediting the survey and ground verification in view of NGT order dated 07/01/2021.

1. To expedite review, Divisions have been asked to deploy more teams and some staff from functional Divisions has also been deputed to territorial Divisions.
2. Further, as 100% enumeration of around 91 SqKm area found for enumeration as per desk analysis, would have been impossible in three months times, 5% sampling methodology for enumeration, as adopted by earlier Review Committee (Deepshikha committee), which has been accepted by Hon'ble NGT and discussed in previous review committee meeting, has been started and a file in this regard also submitted to the state Government. The committee endorsed the action taken.
3. **Five** meetings with Sub-committees held in which Review Committee briefed the detail of the work to be carried out, sorted out coordination issues and reviewed the progress.

Agenda item no 8.3: Review on Repeated survey numbers included in list of Private Forests identified by Thomas and Araujo Committee and the same reviewed by earlier Review Committee(DeepShikha Committee) .

1. The analysis of Sy Nos identified as Private Forest by Sawant and Karapurkar committees and found repeated in Thomas and Araujo Committee was revisited for final status of reviewed survey nos/part survey nos on the principle that those areas which were already reviewed by earlier Review committee are not to be reviewed and only those areas which were not reviewed to be considered for review by this committee. Total 130_ such survey numbers across **39** villages were analysed and out of which **88** have already been completely reviewed by Deep Shikha Sharma review committee and remaining **42** Survey Nos. alongwith its **56** Survey nos Parts needs to reviewed as they were not in the scope of earlier review committee and thus not reviewed.
2. Regarding remaining two lists of Sy Nos not to be reviewed, it was decided:



- i) From the list of Survey nos identified by Thomas and Araujo Committee, **39** Survey Numbers, other than Sawant and Karapurkar Sy No. but included and demarcated as Private Forest by earlier demarcation team of Forest Department has been found. The same (39 Sy Nos) were ratified and included in 46.1 Sq. Km Private Forest land by earlier Review Committee Deepshikha committee and accepted by Hon'ble NGT. Out of 39 Sy Nos, except Sy Nos. 25 and 101 of Keri (Sattari), where full Sy No is repeated, in remaining **37** sy nos undemarcated area will be reviewed .
- ii) From the list of 26 Survey Numbers which are Government Forest and erroneously included as Private Forest by Thomas and Araujo Committees, it was decided to exclude Sy No. pertaining to Proposed Reserve Forest and to review Unclassified Forest in the instant case for further analysis.

Agenda item no 8.4: Review of Survey Nos not meeting area & Canopy criteria as per desk analysis done through superimposition & digitization of Survey numbers on 2014-15 LISSIV forest Cover Map of FSI

Discussion was held on review of the Survey nos not meeting the area & canopy criteria of Private Forest after the digitised Survey nos were analysed through superimposition on LISS IV FCM of 2014-15. As per approved methodology " If a survey number/patch is identified as Forest in Thomas and Araujo committee reports but not from above analysis, concerned Divisions will be asked to check for any records/evidence of tree felling offence case/court case on concerned patch besides checking the area on google time series data . Accordingly decision on inclusion or exclusion of concerned patch will be taken". Accordingly, the committee discussed in detail about analysis of Google timeline, offence cases, felling permissions. It was decided that for significant changes in google timeline/offence cases/felling permission, quantitative corroboration may be done through LISS III images for relevant period, which are readily available and give an objective assessment. In case of doubt in species sample check from ground verification may also be done as and where needed.

Accordingly in all **239** Survey nos were placed for review and based on the findings of the Committee all **239** No of Survey Nos not qualifying Private Forest Criteria were found. It was decided to hold another meeting in a fortnight to review further and submit consolidated report to the Government.

Agenda item no 8.5: Any other matter.

- As decided in previous review committee meeting Survey Nos pertaining to Government project were reviewed as under-

A) **Construction of High Court Building** in S. No. 75 & 76 of Penha De Franca of Bardez Taluka. The S.No. 75 & 76 do not meet the criteria of

more than 40% Canopy density and Area of 5 Ha as per LISS IV FCM of 2014-15 prepared by FSI. Since, tree felling permission was issued in 2014 by DCF (North), the committee did Google timeline analysis and found trees removal in the period. To quantitatively corroborate the Forest cover previous to tree removal, the committee checked the Survey No as per LISS III FCM of 2013 of FSI and found that canopy of whole patch was less than 0.4. Since canopy criteria of Private Forest are not fulfilled, it was concluded that these two survey nos (75 and 76 of Penha de Franca) do not qualify the criteria for Private Forest.

B) **Garbage Disposal Site of Margao Municipal Council** in survey No 196/1B of Raia of Salcete taluka admeasuring 30,000 Sq. mts. Was reviewed. The S.No. 196/1B do not meet the criteria of more than 40% Canopy density and Area of 5 Ha as per LISS IV FCM of 2014-15 prepared by FSI. Nor it is adjoining Government Forest. There is no felling permission/forest offence related with this site reported by DCF (South). No significant change was observed in Google timeline. The Committee based on all the above concluded that Sy No. 196/1B of Raia village does not qualify as Private Forest.

C) **Burial ground at Sonsodo, Margao** in Chalta No. 1 of PT sheet no 50 & 49/19 (Part) was reviewed. Chalta No. 1 of PT sheet no 50 & 49/19 (Part), Margao, do not meet the criteria of more than 40% Canopy density and Area of 5 Ha as per LISS IV FCM of 2014-15 prepared by FSI. Nor it is adjoining Government Forest. There is no felling permission/forest offence related with this site reported by DCF (South). No significant change was observed in Google timeline. The Committee based on all the above concluded that Chalta No. 1 of PT sheet no 50 & 49/19 (Part), Margao, does not qualify as Private Forest.

- The committee decided that the issue of Provisionally identified Survey Nos for which final decision has been taken by Thomas/ Review committees including maps were prepared by Thomas and Araujo committees, to be put up in next meeting of the committee with detailed background note for final view in the matter.
