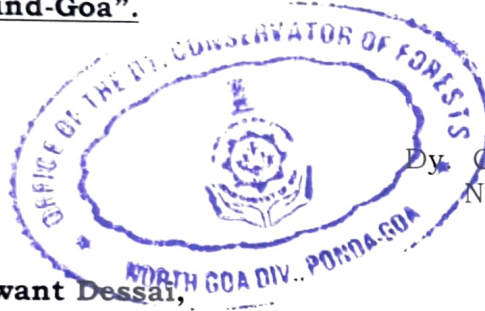



8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated Nos. of saplings otherwise, Security deposit shall be forfeited in "Tree Protection Fund-Goa".
