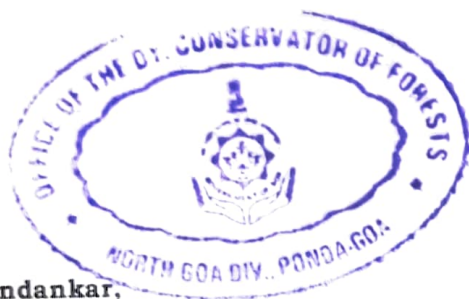



7. The event of failure on the part of permit holder to replant the trees as indicated above, the Trees Office shall take necessary action as per the Goa Preservation of Tree Act 1984.
8. The claim regarding refund of Security Deposit shall be made within the three years from the date of this permission on successful replantation of stipulated Nos. of saplings otherwise, Security Deposit shall be forfeited in "Tree Protection Fund-Goa".
