- 1 The Range Forest Officer shall mark trees before cutting.
- 2 Permission to fell the trees is granted at his/her own risk and without prejudice to the claim of the other person who maybe having any right over the land or trees.
- 3 -The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case trees felling not completed within 45 days application for extension of time limit for felling of tree, shall be forwarded to this office through concern Range Forest Officer
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June2022 in the property from which the trees will be felled.
