Incase trees felling not completed within 45 days' application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
- 4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. He/She shall replant trees as per details given below during the ensuing/next planting season in the property from where the trees will be felled.

- 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of this permission on successful replantation of stipulated Nos. of saplings otherwise, Security Deposit shall be forfeited in "Tree Protection Fund-Goa".
