Terms and conditions

- 1 The Range Forest officer shall mark the tree before cutting.
 - 2 Permission to fell trees is granted at his/her own risk and without prejudice to claim(s) of any other person/s who may be having any right(s) over the land or the trees.
 - 3 **The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission as per the directions of Hon'ble High Court in PIL. Writ Petition No. 08 of 2021. The tree felling maybe completed within 45 days after completing 30 days as mentioned above. Incase trees felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.**
 - 4 Material produced from the felled trees shall not be removed or disposed without permission of the tree officer.
 - 5 Applicant shall replant 6 forestry tree species during ensuing/ next planting season, i.e, commencing from June 2023 to August 2024 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 5/23 of Sirvoi village Quepem taluka.
 6. Licence fee was paid earlier vide R. No. 825/42 dated: 05.10.2023 Rs. 200/- and deposit a sum of Rs 1200 (Rupees One Thousand Two Hundred Only) vide DD No. 560822 dtd. 04.10.2023 as Security Deposit in the office of the Sub Divisional forest officer, South Goa Division, Quepem Goa before starting felling of the tree/s for ensuring the replanting of the trees indicated at Sr.No. 5 above.
 7. The event of failure on the part of permit holder to replant the trees as indicated above, the Trees Office shall take necessary action as per the Goa Preservation of Tree Act, 1984.
 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated nos. of saplings otherwise, Security Deposit shall be forfeited in 'Tree Protection Fund-Goa'.
