

With reference to his/her application dated 24.11.2023 for grant of Permission to fell trees **Shri Madhukar Shanu Narvekar, R/o. H.No.5, ward No.1, Matau wada, Penha de Franca, Britona, Bardez – Goa**, is hereby informed that he/she is granted permission to fell trees (as per detail indicated below) from the private property known as "**Matau**" in Sy.no. **193/1-A** (area **15.00** sq.mts) situated at **Penha- de- Franca** Village **Bardez** Taluka subject to the terms and conditions here under specified.

TERMS AND CONDITIONS

- 1 - The Range Forest Officer shall mark trees before cutting.
- 2 - Permission to fell the trees is granted at his/her own risk and without prejudice to the claim of the other person who maybe having any right over the land or trees.
- 3 - **The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case trees felling not completed within 45 days application for extension of time limit for felling of tree, shall be forwarded to this office through concern Range Forest Officer.**
- 4 - Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 - He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2023 in the property from which the trees will be felled.

- 6 - To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.
- 7 - He/She has paid of Rs. 200/- vide Receipt No. 09 /822 dtd: 01/12/2023 as fee. He/She has deposited FDR/DD/Call Deposit Receipt sum of Rs. 1200/- (**One Thousand Two Hundred only**) vide **FDR/DD/Call Deposit Receipt No. 12099** dated. 29/11/2023 as security in the name of **Tree Protection Fund-Goa**.
- 8 - In the event of failure on the part of permit holder to replant the tress as indicated at serial No. above. Then the Tree Officer shall himself arrange to replant the trees and recovery the expenditure as Areas of land Revenue.
- 9 - The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated numbers of saplings otherwise, Security deposit shall be forfeited in "**Tree Protection Fund-Goa**".
