Terms and conditions

- The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
- 3. The actual tree felling shall be carries out after 30days from the date of issue of this tree felling permission as per the directions of Hon'ble High Court in PIL. Writ petition No.08 of 2021. The tree felling may be completed within 45 days after completing 30days as mentioned above. Incase trees felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. He/She shall replant tree as per details given below during ensuing/next planting season i.e. commencing from June 2024 to Nov. 2024 in the property from which the trees will be felled. Replanting should be done as per the replanting plan submitted by the applicant in Sy.No. 36/1 of Cotigao village of Canacona taluka. No. of trees

- 6. License fee was paid earlier vide R. No. 851/03 dtd. 11/03/2024 for Rs.2000/- and deposit a sum of Rs.6000/- (Rupees six thousand only) vide D.D.No.356727 dtd 08/03/2024, as Security Deposit in the office of the Sub Divisional Forest Officer, Canacona-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr.No.5 above)
- 7. In the event of failure on the part of permit holder to replant the trees as indicated above, the Trees office shall take necessary action as per the Goa Preservation of Tree Act, 1984.
- 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated nos. of saplings otherwise, Security Deposit shall be forfeited in "Tree Protection Fund-Goa"
