- 3. The actual tree felling shall be carries out after <u>30days</u> from the date of issue of this tree felling permission as per the directions of Hon'ble High Court in PIL. Writ petition No.08 of 2021. The tree felling may be completed within <u>45 days</u> after completing 30days as mentioned above. Incase trees felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
- Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
