ORDER

With reference to the letter received from **Goa State Urban Development Agency (GSUDA), Panaji Goa** dtd. 18/03/2024, after careful examination of the matter, and as per the powers conferred on undersigned **sub-section (1) of Section 12-A of GPTA, 1984** as the Tree Officer having jurisdiction over the area, permission is hereby conveyed for cutting of 01 No. Raintree, standing in ruinous state and leaning towards adjoining structure posing danger to vehicular traffic and public, subject to following Terms and Conditions:-

1. The cutting of tree shall be carried out after receipt of all other statutory permissions from competent authority, as applicable.
2. Felling of tree is to be supervised by Range Forest Officer, Panaji and representative of Goa State Urban Development Agency (GSUDA), Panaji Goa.
3. **A separate register showing details of felling (like tree No, number of logs made out of each tree etc.) needs to be maintained. The same shall be produced to the officer inspecting the site.**
4. **Felling of tree shall be completed before 15th April, 2024.**
5. **To compensate the loss, User Agency is hereby advised to plant tall saplings with good endurance with minimum 8-10 feet height and 10cm diameter at 1 mtr. Height from ground level.**
6. **It is advised to replant 03 Nos. of tree saplings in lieu of felling of 01 No. trees in their own land and submit compliance report, by the Range Forest Officer, Panaji.**


