- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.

- 4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. He/She shall replant tree as per details given below during ensuing/next planting season, i.e. commencing from June 2024 to August 2025. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 155/1-C of Cortalim village of Mormugao taluka.

- 6. Licence fee was paid vide R. No. 42/847 dtd. 04/03/2024 for Rs. 15000/- and deposit a sum of Rs. 45000/- (Rupees Forty five thousand only) vide D. D. No. 895598 dtd. 27/02/2024, as security Deposit in the office of the Dy. Conservator of Forests, South Goa Division, Margao-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr. No. 5 above).
- 7. The event of failure on the part of permit holder to replant the trees as indicated above, the Trees Office shall take necessary action as per the Goa Preservation of Tree Act, 1984.
- 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated nos. of saplings otherwise, Security Deposit shall be forfeited in <u>'Tree Protection Fund-Goa'</u>.
- 1. Copy to the Conservator of Forests, Panaji Goa for information.
- 2. Copy to the **RFO**, **Mobile Squad Margao** w.r. to his report dated 22/11/2023. He is directed to keep strict watch over the felling of 15 nos. of trees and ensure that no illegal felling takes place.
- 3. Copy to the Chairman/Secretary, Cortalim, Biodiversity Management Committee, Village Panchayat, Cortalim, Mormugao Goa to followup replanting of trees.
