In case trees felling not completed within 45 days application for extension of time dimit for felling of tree, shall be forwarded to this office through concern Range Forest Officer.
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June2024 in the property from which the trees will be felled.
