- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell trees is granted at his/her risk and without prejudice to claim(s) of any other Person/s who may be having right/s over the land or trees.
- 3. The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission as per the directions of Hon'ble High court in PIL Writ Petition No. 08 of 2021. The tree felling may be completed within 45 days after completing 30 days as mentioned above, In case trees felling not completed within 45

5. He/She shall replant tree as per details given below during ensuing/ next planting season i. e. commencing from June 2024 to August 2025. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 214/5 of Curtorim village of Salcete taluka.

- 6. License fee was paid vide R. No. 48/847 dtd. 14.03.2024 for Rs.3,000/- and deposit a sum of Rs. 6,000/- (Rupees Six thousand only) vide D.D. No. '080708' dtd. 12.03.2024, as security Deposit in the office of the Dy. Conservator of Forests, South Goa Division, Margao-Goa, before starting felling of the tree/s for ensuring the replanting of the trees (indicated at Sr. No. 5 above)
- 7. The event of failure on the part of permit holder to replant the trees as indicated above, the Tree Officer, shall take necessary action as per the Goa Preservation of Tree Act, 1984.
- 8. The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated nos. of saplings otherwise; Security Deposit shall be forfeited in 'Tree Protection Fund-Goa'

- 2. Copy to the **R.F.O**, **Mobile Squad**, **Margao-Goa**, w. r. to his report dated 26.02.2024. He is directed to keep strict watch over the felling of **03 no/s**. of tree/s and ensure that no illegal felling takes place.
- 3. Copy to the Chairman/Secretary Curtorim Biodiversity Management Committee, Village Panchayat, Curtorim, Salcete-Goa to follow-up replanting of trees.
