The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case trees felling not completed within 45 days application for extension of time limit for felling of tree, shall be the warded to this office in ough concern Range Forest Officer.
- 4 Material produced from felled trace shall be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replain trees as per details given below during the ensuing/next planting season i.e Commencing from June 2024 in the property from

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.
