- 2 Permission to fell the trees is granted an MHStowisk and without prejudice to the claim of the other who maybe having any right over the land or trees.

 3 The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed whitin 45 days after completing 30 days as mentioned above. In case trees felling not completed with 15 days application for extension of time limit for felling of tree, shall be forwarded to this office through togern Range Forest Officer.
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2024 in the property from which file sees will be felle

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.

- 8 In the event of failure on the part of permit holder to replant the tress as indicated at serial No. above. Then the Tree Officer shall himself arrange to replant the trees and recovery theexpenditure as Areas of land Revenue.
- 9 The claim regarding refund of Security Deposit shall be made within the three years from the date of issue of this permission on successful replantation of stipulated numbers of saplings otherwise, Security deposit shall be forfeited in "Tree Protection Fund-Goa".
