- 4 Material produced from felled tre es shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below turing th e ensuing/next planting season i.e Commencing from June 2024 in the property from which the

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.
