## TERMS AND CONDITIONS

- 1. The Range Forest Officer shall mark the trees before cutting.
- 2. Permission to fell the trees is granted at his/her own risk and without prejudice to the claims of the other person/s who may be having any right over the land of trees.
- 3. The actual tree felling shall be carried out after 30 days from the date of issue of this Tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case tree felling not completed within 45 days application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
- 4. Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5. Hc/ She shall replant trees as per details given below during the ensuing/next planting season i.e. commencing from June 2024 to Sept 2024 in the property from where the trees will be felled.

- 6. He/ She has deposited a sum of Rs.1200/- (Rupees One Thousand Two Hundred only) as Security deposit (As per the Secretariat Notification Order No.7/2/2023-FOR/190 Dated:-28/08/2024 & Official Gazette published on dated 05.09.2024) in the Office of the Dy. Conservator of Forests, before starting the felling of trees for ensuring the Replanting of trees indicated as serial No. 5 above.
  - 7. In the event of failure on the part of permit holder to replant the trees as indicated above, the Trees Office shall take necessary action as per the Goa Preservation of Tree Act1984.
