Sub.-:Submission of Rectification of Blackspots between Pratap Nagar Dharbandora to Petkem Km 114 to Km 113/750 (i.e Pansulem Piliem to Sugar factory on NH-748 in the State of Goa.


With reference to your letter dtd. 06/06/2024 on the cited above subject and as per official Gazette Govt. of Goa dtd. 07/10/2022 the GPTA was amended (point No. 9 Amendment of Section 30) and made applicable to Government land also permission of Forest Department is hereby conveyed for felling of 43 Nos. of trees under Sy. No. 12/2, 21/1, 24/1, 46/3, 23/1 and 52 of Piliem village of Dharbandora taluka, for Rectification of Blackspots between Pratap Nagar Dharbandora to Petkem Km 114 to Km 113/750 (i.e Pansulem Piliem to Sugar factory on NH-748 in the State of Goa, subject to following Terms and Conditions:-

1. In case of any claim/litigation about the ownership of the trees/land in question, the user agency will be solely responsible.
2. The cutting of tree shall be carried out after receipt of all other statutory permissions from competent authority, as applicable.
3. Date of beginning for felling of tree is to be intimated to Range Forest Officer, Ponda well in advance.
4. A separate register showing details of felling (like tree No, number of logs made out of each tree etc.) needs to be maintained by the user agency. The same shall be produced to the officer inspecting the site.
5. The actual tree felling shall be carried out after 30 days from the date of issue of this tree felling permission. The tree felling may be completed within 45 days after completing 30 days as mentioned above. Incase trees felling not completed within 45 days' application for extension of time limit for felling of trees, shall be forwarded to this office through concern Range Forest Officer.
6. To compensate the loss User Agency/Applicant is hereby advised to plant tall saplings with good endurance with minimum 8-10 feet height and 10cm diameter at 1 mtr. Height from ground level.
7. User Agency has to replant 129 Nos. of saplings and maintain thereafter for 5 years at their cost and report compliance to this office.

User Agency has submitted Demand Draft of Rs. 1,46,200/- Vide No. 332693 dated 08/10/2024 of Bank of Maharashtra, Panaji Branch towards Tree felling fees and Security Deposit in Favor of "Tree Protection Fund-Goa" and the amount of Security Deposit is refundable on compliance of replantation of 129 Nos. of trees.
