The tree felling may be completed within 45 days after completing 30 days as mentioned above. In case trees fulling not completed within 45 days application for extension of time limit for felling of tree, shall be forwarded to this office through concern Range Forest Officer.
- 4 Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.
- 5 He/She shall replant trees as per details given below during the ensuing/next planting season i.e Commencing from June 2024 in the property from which the frees will be felled.

- 6 To compensate the loss user Agency/Applicant is hereby advised to plant trees with good endurance with minimum 8-10 feet height.
