- 3 - The actual tree fellling shall be carried out after 30 days from the date of issue of this tree fellling permission. The tree fellling may be completed within 45 days after completion of 30 days as mentioned above. In case trees fellling not completed within 45 days after completion of time limit for fellling above, who may be having any right over the land or trees.
- 2 - Permission to fell the trees is granted at his/her own risk and without prejudice to the claim of the other person.
- 1 - The Range Forest Officer shall mark trees before cutting.
