2. The date & time of opening of online tender is 06 /01/2022 upto 16.00 hrs in the office of the Dy. Conservator of Forests, Wildlife & Eco- Tourism (North) Division, 1st lift, 4th floor, Junta House, Panaji- Goa.

The online application should accompany the following documents (Scan & Upload on the e-tender website):

1. Attested copy of Valid Registration certificate.
2. Attested copy of PAN card.
3. Attested copy of GST registration certificate and ARN copy.
4. Attested copy of Authorized Dealer Certificate
5. Mode of payment towards cost of the tender Document, EMD & tender Processing fee: to be paid online through e-payment Mode via NEFT/RTGS/net banking with pre-printed challans available on e- tendering website and directly credit the amount of ITG account as generated by challans for NEFT/RTGS.
6. The Applicant should upload the scanned copy of the declaration in prescribed format (Annexure-A) giving the names of the works in hand in the above mentioned category on stamp paper of Rs. 50/-

INSTRUCTIONS TO CONTRACTORS/SUPPLIER

1. The intending bidder must read the terms and conditions of tender document. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. This is two bid system. Therefore requested to submit technical and financial bid separately in the website itself.
3. Information and instructions for bidders posted on website shall form part of bid document.
4. The bid document consisting of specifications, suppliers to be complied with and other necessary documents can be seen and downloaded from website <https://eprocure.goa.gov.in>

5. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have/obtain in a valid class III digital signature to submit the bid.
7. On opening date, the suppliers can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Bidder must ensure to quote rate of each item.
9. In addition to this, while selecting any of the cells a warning appeared that if any cell is left blank the same shall be treated as "0" & will be treated as incomplete tender & will be rejected outright. Also name of the bidder should be entered in respective cells .
10. The tenderer shall be responsible for the correctness and genuineness of the documents uploaded during tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
11. No Hard Copies of the documents to be submitted in the tender box.
12. After work order supplier should give demo to the Range Forest Officer Campal and Jetty will be located at Dr. Salim Ali Bird Sanctuary Chorao.
13. Bidders should apply as per Specification Enclosed
14. Bidders who are applying below 20% of estimated cost will be rejected and also who are applying above 5% of estimated cost will be rejected.
15. Resubmit the Annexure-I after filling the necessary details.
16. The supplier shall Obtain all necessary Permission, license from the Competent Authority.
